Ms. Anastos received the 2020 Artist of the Future Award, the 2021 Certificate of Artistic Excellence, and is currently a finalist for Artist of the Year Award through the Circle Foundation of the Arts (CFA) 2022. Ms. Anastos is known for her colorful, profound, and uplifting paintings.

All her paintings have a story, a piece of her soul, a raison d'être.

Her voice in fine arts has been influenced by the Impressionism and Post-Impressionism painters for her figurative compositions, and some Modern artist for her abstract compositions, such as Mondrian and Mirò. She likes to say that sometimes, the ghost of Maestro Salvador Dali visits her while she sleeps and dreams, and some of her surreal compositions come to life.

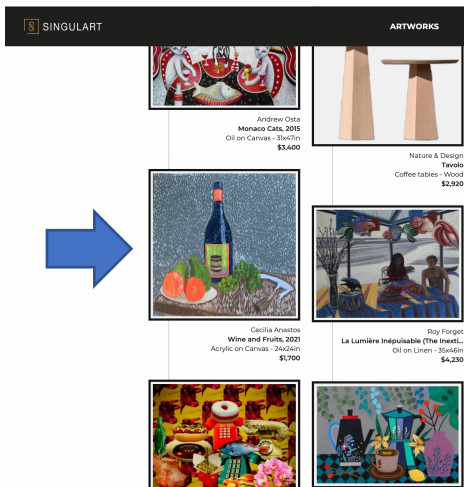

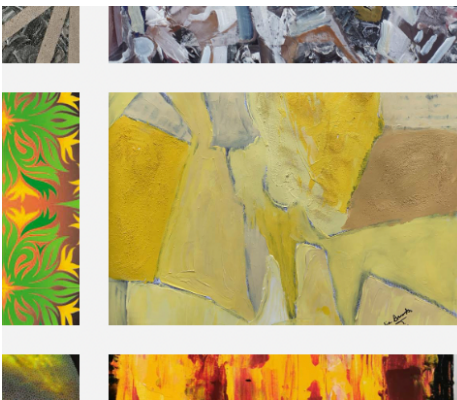
